1. Discussion Item – Seismic Safety Program	<ul> <li>The 2017 revision of the seismic policy requires all campuses to implement remediation plans of seismically deficient buildings (performance ratings equal or below to 5) by 2030.</li> <li>Buildings with seismic performance rating of VI: Donner Lab Addition, Durant Hall (base isolation), Evans Hall, Moffitt Library (targeted strengthening of connections of girders/columns), Stephens Hall (new shear walls and foundation), Wellman Hall (new shear walls and foundation), Wellman Hall (new shear walls and foundation), Wellman Hall (new shear walls and foundation), and Davis Hall.</li> <li>Note: Buildings in bold are replacement buildings and the remaining ones are scheduled for retrofit, with retrofit strategies in parentheses. Retrofits requires upgrading the buildings to new building codes, including those for accessibility and life safety.</li> <li>UCOP will also consider including deferred maintenance assets identified by ICAMP that will likely fail within the next three years. The decision is externally driven. The campus can also consider selffunding the deficiencies not identified by ICAMP.</li> <li>Note: Cost estimates from ICAMP are not reflective of final project costs because they only account for construction costs.</li> <li>The UC system currently has \$300 million to improve the seismic safety of buildings and will receive an additional \$2 billion if AB 48 is approved by voters on March 2020.</li> </ul>	<ul> <li>Conduct a more holistic review of the retrofit buildings</li> <li>Submit Project Planning Guides to UCOP in mid- December for funding approval</li> </ul>
